- The Schedule of submission of examination forms may please be followed strictly in letter and spirit. In case of delay of <u>even one day</u>, the Heads of the Institutions shall have to pay the late fees as mentioned above.

INSTRUCTIONS

- The blank Examination Forms can be obtained from the nearest Habib Bank Limited Branch on payment of Rs.100/- each form against requisition letter from the Head of the Institution concerned.
- 2. The particulars of candidate i.e Name/Father's Name/Surname and Date of Birth may be filled in and verified carefully and properly from the School General Register. It should be noted that any wrong/incorrect entry made by Head of Institution will be treated the fault of concerned institution.
- 3. While filling the Examination Forms of Class (X), particulars of the candidates must be checked carefully if any discrepancy is found in Marks Certificate of (IX) Class the same may be got corrected from the Board, before filling up the Examination Forms of Class (X). the particulars of the candidates on the Examination Forms of Class (X) if found different as per attached Marks Certificate of Class (IX) such Examination Forms of candidates will be returned and will not be entertained.
- 4. Home address of candidate may clearly be shown in his/her own hand writing.
- 5. It is compulsory to attach Original Marks Certificate of (Class-IX) i.e. of previous Examination with all the Examination Forms of (Class-X).
- 6. The Marks of Identification of each candidate must be written at the space provided in Examination form.
- 7. Attested Photocopy of Enrollment Card or counter foil Enrollment form issued by this office must be pasted with the gum on the back side of (Class-IX) only.
- 8. The original letter of permission for improvement of Grade/Marks (if applicable) must be attached with the Examination Form of Class-X.
- 9. Candidates who were enrolled/appeared through any School/Higher Secondary School in (Class-IX) previously, the examination forms of such candidates be forwarded from the same School/ Higher Secondary School. In case of Transfer Certificate (T.C) the original permission letter issued by the Board must be attached with Examination form. No such Examination form be forwarded without T.C permission.
- 10. In case a candidate is coming from other Board, the original Marks Certificate of last Examination and Eligibility Certificate in original issued by the Academic Section of BISE, Larkana should be attached with Examination Form and No such Examination Form be forwarded without Eligibility Certificate (E.C) of the Board.
- 11. All the Examination Forms of Regular candidates of (Class-IX) must be set alphabetically and group wise, whereas Examination forms of (Class-X) Regular candidates must be set according to the previous Seat No. of (Class-IX).
- 12. The subjects of the candidates in which, they intend to appear in ensuing examination be clearly mentioned in the examination forms at particular places as per their previous Marks Certificates. If any paper/subject is left un-turned, the Board will not be responsible for any mistake/error.
- 13. Stamp Signature of Head of Institutions on the Examination forms is not allowed, such forms should be returned to the concerned Head of Institution.

14. FOR PRIVATE CANDIDATE

- (i) Private candidates shall have to produce an attested photocopy of Domicile/PRC issued by the Deputy Commissioner/District Coordination Officer of concerned district and Primary Certificate of Class-Vth.
- (ii) Attested photocopy of Computerized National Identity Card must be attached with the Examination Form. In case of candidate is below age of 18 years their attested photocopy of form "B" from Registration Department of his/her Father/Guardian be attached.

ATTENDANCE 15.

- In case of regular student the attendance kept by the candidate should be (i) shown in the column meant for it up to 01/12/2017 average attendance must be indicated separately, average shall however, be worked out keeping in view the previous record of actual attendance kept by the candidate. The minimum attendance required 75% of total period attended. The examination forms of those candidates whose attendance fall short should not be entertained. All column of attendance in examination form must be filled in properly.
- In case any candidate exhibits irregularity in attendance his/her Examination (ii) Form may not be forwarded to the Board.

ELIGIBILITY OF CANDIDATES 16.

- The candidates who were enrolled and have appeared at SSC Part-I (Class-IX) (i) Annual Examination 2016, and could not appear at SSC Part-II (Class-X) Annual Examination 2017, can appear at SSC Part-II (Class-X) Annual Examination, 2018 subject to production of Admission Certificate of (Class-X) from the concerned Head of Institution within due date. (In case of Regular Candidates).
- The candidate, who appeared first time at SSC Part-II (Class-X) (ii) Annual Examination, 2016 and then whether they appeared or not SSC Part-II (Class-X) Annual/Supplementary Examination, 2017 and could not qualify the same, can appear in failure papers of SSC Part-I & II (Class-IX & X) at Annual Examination 2018 as Ex. Student.
- The candidates who first time appeared at the SSC Part-I (Class-IX) Annual (iii) Examination, 2014 are not eligible to appear at the SSC Part-II (Class-X) Annual Examination 2018, hence their examination forms may not be referred to the Board. (if such form is received from any School/ Higher Secondary School authorities that will be entirely on their own risk and cost and will be rejected (and the examination fees will not be refunded).
