1. If an institution fails to submit enrollment forms upto 30/09/2019, then, a penalty of Rs. 5/- (Five Rupees) per candidate/per day shall be charged w. e. f. 01/10/2019 to 31/12/2019.
2. Institutions are required to Log on to the Board's website www.biseatd.edu.pk for online enrollment module for class 8th regular students and submit the same alongwith the requisite fee within the due date, In case of delay in submission of enrollment, late fee will be charged. (For any details/query contact 0992-392727 during office hours).
3. Particulars of student(s) Name, Father Name, Date of Birth, Admission Number and Date of admission must be in conformity with admission withdrawal register. Any cutting, overwriting, erasing and alteration in above particulars of student(s) will not be accepted.
4. The age limit for a candidate will be 13 years on the commencement date of (Class 8th) Middle Standard Annual Examination 2020.
5. School to School Migration (Local Migration) shall not be allowed under any situation after 31-12-2019. The Heads of institutions are also advised never to sign migration form after due date i. e. December 31, 2019. In such situation, Board is authorized to refuse or take disciplinary action as the case may be.
6. Institutions are required to provide their Telephone/Cell numbers and complete mailing address to this office for ready use.
7. The Heads of Government and Private Institutions are required to deposit the below mentioned fee for extension in annual affiliation on the prescribed bank slip along with covering letter/Performa signed by Principal/Headmaster/Headmistress of the concerned institution. (Extension in registration of Private Institutions by KPPSRA is also mandatory).
