NOTE: THE LAST DATE FOR ENROLMENT OF CLASS 8<sup>TH</sup> IS November 08<sup>th</sup>, 2019.

- 1. If an institution fails to submit enrollment forms upto 08/11/2019. Then a penalty of Rs.5/- (Five Rupees) per candidate / per day shall be charged w.e.f. 09/11/2019 to 31/12/2019.
- 2. The head of Institutions are advised to adopt the procedure of online enrollment through portal system (portal bisedik.edu.pk) for 8<sup>th</sup> class regular students and submit along with requisite fee within due date to this office for confirmation physically otherwise fee shall be charged as per portal system received. Manual Enrollment return shall not be accepted and strict disciplinary action be taken against the institution.
- 3. Particular of student(s) Name. Date of Birth. Admission Number and Date of admission must be in conformity with admission withdrawal register. Any cutting overwriting erasing and alteration in above particular of student(s) will not be accepted.
- 4. The age limit for a candidate will be 13 years on the commencement date of (class 8<sup>th</sup>) Middle Standard Annual Examination 2020.
- School to School migration in case of class 8<sup>th</sup> (Local Migration) shall not be allowed under any situation after 31/12/2019. The head of institution are also advised never to sign migration form after due date i.e.
  31/12/2019 in such situation, Board is authorized to refuse or take disciplinary action as the case may be.
- 6. Institutions are required to provide their telephone / Cell numbers and complete mailing address to this office for ready use.
- 7. The Heads of Government & Private Institutions are required to deposit the below mentioned fee for extension in annual affiliation on the prescribed bank slip along with covering letter / Proforma signed by Principal / Head Masters/ Head Mistress of the concerned institute. (Extension in registration of Private institutes by KPPSRA is also mandatory,
- 8. The Head of the institutions are directed to submit the following documents of Migrated students from other Boards within fortnight for enrolment to this office. If an institution failed to provide the same a penalty would be imposed on the institution.
  - A. Original Migration Certificates
  - B. C/Signed copy of school leaving certificate.
  - C. Enrollment form return along with reference letter duly signed by the head of the institution concerned.
  - D. Prescribed Fee.

- 9. A student will not be admitted or enrolled until Original School to School Migration Certificate and School Leaving Certificate is submitted. In case of non provision of the above, the penalty will be imposed on the institution.
- 10. The Head of the institution are advised to deposit the enrollment fee for the session 2019-2020 in HBL & UBL branches under the jurisdiction of BISE, D.I.Kha.
