- 1. If an institution fails to submit enrollment forms up to 08/11/2019, a penalty @ Rs.05/- (Rupees Five) per day per student shall be charged up to last date of admission forms.

- 3. The age limit for a candidate will be Thirteen (13) years on the commencement date of (8th Class) Middle Standard School (Annual) Examination, 2020.
- 4. The Heads of the Institutions are directed to submit the following documents of migrated students from other boards within fortnight for enrollment to this office. If an institution is fails to provide the same, a penalty would be imposed on the institution.
 - (A) Original Migration Certificate
 - (B) C/Signed copy of School Leaving Certificate.
 - (C) Enro<mark>llment form/return along with reference letter dul</mark>y signed by the head of instituti<mark>on c</mark>oncerned (D) Prescribed Fee.
- A student will not be admitted or enrolled until <u>Original School to School Migration Certificate and School Leaving Certificate</u> is submitted, in case of non provision of the above; the penalty will be imposed on the institution.
- 6. School to School Migration(Local Migration) shall not be allowed under any situation after December 31, 2019 till the declaration of annual Middle Standard School Examination Result 2020.
- 7. All the students seeking migration are required to submit photocopy of School Leaving Certificate (S.L.C) along with prescribed form.
- The Heads of the Institutions are advised never to sign migration form after due date i.e. December 31,
 2019. In such situation board is authorized to refuse or take disciplinary action.
- The Heads of the Institution are advised to deposit the enrollment fee for the session 2019-2020 in NBP branches within the jurisdiction of BISE Kohat.
