  - b) Five sets of duly filled in **Security Clearance Proforma** (downloaded from FPSC website - [www.fpsc.gov.pk](http://www.fpsc.gov.pk)).
  - c) Educational profile proforma (sent to written qualified candidates via post).
  - d) Undertaking (sent to written qualified candidates via post).
  - e) Two recent passport size photographs.
3. In case of failure to bring the requisite documents, the candidate will not be allowed to appear in the Psychological Test. Furthermore, if a candidate remains absent in the Psychological Test, he/she will not be allowed to appear for Viva Voce.
4. Four copies of Preference Form (sent to written qualified candidates via post) are to be furnished at the time of Viva Voce.
5. **Schedule of Viva Voce will be intimated later on.**
