- 1. Candidates are required to bring all **original documents** for verification.
- 2. Candidates are also required to submit the following at the time of Psychological Test:-
 - a) Duly filled and signed Application Form for CSS-2019 (downloaded from FPSC website - www.fpsc.gov.pk) alongwith attested photo copies of all supporting documents.
 - b) Five sets of duly filled in **Security Clearance Proforma** (downloaded from FPSC website www.fpsc.gov.pk).
 - c) Educational profile proforma (sent to written qualified candidates via post).
 - d) Undertaking (sent to written qualified candidates via post).
 - e) Two recent passport size photographs.
- 3. In case of failure to bring the requisite documents, the candidate will not be allowed to appear in the Psychological Test. Furthermore, if a candidate remains absent in the Psychological Test, he/she will not be allowed to appear for Viva Voce.
- 4. Four copies of Preference Form (sent to written qualified candidates via post) are to be furnished at the time of Viva Voce.
- 5. Schedule of Viva Voce will be intimated later on.
