## NOTIFICATION FOR CANDIDATES HAVING LAST CHANCE IN FBISE EXAMINATION

It is hereby notified for general information of all concerned that the candidates (**IMPROVEMENT AND COMPARTMENTAL CASES**) having their last chance to appear in the examination are eligible to appear in the **SECONDARY SCHOOL CERTIFICATE (SSC) SPECIAL ANNUAL EXAMINATION, 2020** of the Federal Board of Intermediate and Secondary Education, Islamabad commencing with effect from **Wednesday, the 23<sup>rd</sup> September 2020**.

2. The schedule for receipt of printed copy of Admission Forms along with Admission Fee in the Board Office for such candidates is as under:-

**NOTE:**

- The candidates should ensure that their printed copy of admission form(s) along with prescribed fee should reach the Board's office on or before the last date specified above to avoid payment of extra fee or rejection of form(s).
- A candidate appearing in any subject(s)/paper(s) will pay full fee of his/her respective part/group.
- No fresh candidates are allowed to appear in Special Annual Examination 2020.
- The candidates of Gilgit, Baltistan (Gilgit/Skardu) should submit their admission forms to FBISE's Sub Office, Gilgit & Skardu, Baltistan as per admission schedule.

3. MODE OF SUBMISSION FOR COMPARTMENT CANDIDATES:-

The compartmental candidates that have the last chance to appear in FBISE examination **should fill in only the required fields in the online Admission Form available on FBISE web-site i.e. [www.fbise.edu.pk](http://www.fbise.edu.pk)**, shall sign the Admission Form (Printed Copy), deposit the required fee and submit the printed copy of computerized admission form along with original challan receipt (**Board's Copy**) within given due dates to the Controller of the Examinations (Conduct) by post or at One Window Cell of FBISE. These forms do not require any attestation.

4. MODE OF SUBMISSION FOR IMPROVEMENT CANDIDATES:-

The candidates who have last chance to improve their Grade/Marks after passing SSC Supplementary Examination 2019 can do so by re-appearing in any number of subjects/papers of their choice or Part-I or Part-II or both the Parts/entire examination. The candidates appearing in any subject (both the papers) involving practical examination shall appear in the practical examination as well. However, candidate neither require nor can appear in practical if he/she is appearing in a paper of a subject or any one part of the examination. The candidates should fill in the online Admission Form available on FBISE web-site i.e. [www.fbise.edu.pk](http://www.fbise.edu.pk) and submit the printed copy of computerized admission form along with requisite original challan receipt (Board's Copy) within given due dates to the Controller of Examinations (Conduct) by post or at One Window Cell of FBISE.

5. **MODE OF REMITTANCE OF FEE FOR CANDIDATES IN PAKISTAN:-**

Admission Fee shall be remitted at any nearest branch of Habib Bank Ltd. through computerized Bank challan slip which can be downloaded from FBISE web site i.e. www.fbise.edu.pk. Original Board copy of fee challan must be sent to Board's office along with printed copy of computerized admission form within specified due dates.

6. **MODE OF REMITTANCE OF FEE FOR CANDIDATES IN ABROAD:-**

For remittance of fee to the FBISE account, the overseas candidate(s) may exercise one of the following options:-

- a. The payment may be made through SWIFT "MT-103" purpose in "Filed 70" (Via Commercial channel Instead of home remittance (PRI)) for credit into **FBISE Pak Rupee Account Swift Code: HABBPCCA IBAN Code No. PK26HABB 0022 1100 5000 2001** at the Habib Bank Limited, FBISE Branch, Sector H-8/4, Islamabad (Pakistan), (Nature of fee must be mentioned while preparing Swift MT 103 form/text) OR FBISE US dollar account (IBAN) **PK 79 HABB 0022 1179 0068 7511** (for US dollar remittance only) at Habib Bank Limited, FBISE Branch, H-8/4, Islamabad.
- b. Payment may be made through Bank Draft drawnable at Islamabad (Pakistan) issued in favour of Controller of Examinations (Conduct), Federal Board of Intermediate & Secondary Education, Islamabad. **Any Bank Draft/Electronic Transfer in foreign currency, drawnable in a foreign country (other than Pakistan) will not be accepted at any cost.**
- c. **Payment may be made through Credit Card (Master or Visa) from FBISE website.**
- d. The candidates forwarding admission forms from KSA and UAE may remit the dues/examination fee through following banks to HBL, FBISE account:-
