✓ As per Notification No: SO(B & U)9-3/2017 dated. 20-04-2017 of Education & Literacy Department, Govt. of Sindh Karachi the students studying in public sector institutions are exempted from paying the actual examination fee i.e. (a) Class - XI fee= 940/- (b) Class - XII fee= 920/-

✓ However the public sector (Govt. Institutions) candidate(s) will pay the following fees, which is for documents which are issued to candidate(s) by B.I.S.E Hyderabad, therefore the fee chargeable from each candidate will be (a) Class - XI fee= 1070/- (b) Class - XII fee= 1270/- and also penalty for late submission of Examination Forms, 'the dates of accepting Examination Forms along-with penalty will be as same as mentioned in the main fee schedule given below in this notification'.

The candidates coming from "Other Boards" should submit the Provisional Permission Letter obtained from this Board and Enrolment Card (Photostat copy) and Marks Certificate (Photostat Copy) of S.S.C Part-II (of their previous Board) along-with the Examination form of H.S.C Part-I. After receiving their Original Eligibility Certificate they must submit their Original Eligibility Certificate to H.S.C Conduct Branch so that their result may not be with-held, in case of non-submission of Original Eligibility Certificate their result will be with-held. The candidates which have passed the H.S.C Part- I from any other Board and now wants to appear in H.S.C Part-II from B.I.S.E Hyderabad will also be required to provide Marks Certificate (Photostat Copy) of H.S.C Part-I (of their previous board) including Original Eligibility Certificate and Enrolment Card (Photostat Copy) duly obtained from this Board as required Vide Notification No. BISE/HSC/C/3396-3397 Dated. 03-12-2012.
2. The candidates who applied for the permission of improvement of grade/additional qualification/change of group should submit their examination forms along-with prescribed fee and Photostat copy of Class – XII marks certificate from their respective institutions.
3. The candidates who are going to avail the "non-restriction of chances" (ex-candidates) facility announced by this Board will also have to submit their examination forms along-with prescribed fee from their respective institutes, in case of permanent closure of their institute they are allowed to submit their examination form forwarded by any public sector institute (government institutes).

INSTRUCTIONS FOR HEADS OF INSTITUTIONS / CANDIDATES

1. Three copies of the "Fees Statement" along-with two copies of the List of the candidates in ALPHABETICAL ORDER and group-wise as per specimen Proforma provided be sent with Examination Forms at every occasion. In addition to this, a list of remaining candidates whose form are still awaited may also be provided with the actual attendance kept by the date of first submission of the Examination forms for Annual Examination-2022 as per Proforma given below.

3. The private Female & Male Candidates who appeared in H.S.C (Part-I) Class-XI from any institute affiliated with B.I.S.E Hyderabad and now wants to change their institute to H.S.C Part-II (Class-XII) are allowed to change their institution without obtaining transfer certificate from this Board and their Examination Forms will be accepted through the Principals of Girls or Boys College and the candidates who are appearing in H.S.C (Part-I) Class – XI are required to obtain Enrollment Cards from this board.
4. Each Examination Form must be filled-in carefully and checked from the relevant marks certificates and other records of the Institution are presented correctly by the candidate.
5. The Heads of Institutions are requested to check Examination Forms carefully before forwarding the same to the Board to avoid mistakes in the particulars of the candidates (Name/ Father's Name & Surname).
6. That each candidate (Regular/Private) is required to fill-up the Examination Form of the proper "group" for which he/ she has been enrolled in this Board by recording the Enrolment Card Number at the appropriate place.
7. In-complete Examination Forms will be returned to the concerned Principals, which will be re-submitted after due compliance within a period of one week, failing which the running late fee shall be charged, hence delay be avoided.
8. Two photographs of male as well as of female candidates (with white background) be provided i.e. ONE duly attested by the Principal concerned be pasted with gum at the space provided in the Examination Form and other without attestation be pasted at the proper place for the purpose of scanning.
9. Particulars of each candidate i.e. Name/ Father Name/ Surname must be shown in the "Block Letters" in the columns provided in the form and subjects/ papers Tick-Marked (✓). The "original Marks Certificates" of the lower examination must be attached.
10. Home address of each candidate be clearly recorded in the Examination Form in legible hand-writing.
11. In case of Regular candidates (75% attendance kept in each subject/ paper) should be shown in the columns meant for it, till the date of submission of forms average attendance for the remaining period up to 10.04.2022 may also be indicated in the form separately. Average attendance shall however be worked-out keeping (via online or regular classes) in view the previous record and actual attendance kept by the candidate during academic year 2021 - 2022.
12. In case any candidate exhibits irregularity in attendance, his/ her name may be recommended for "withdrawal" of the "Examination Form" and he/ she will not be allowed, to take the examination. This must be announced in the class rooms as well the contents must be pasted on the Notice Board of the Institution.
13. Any Regular candidate, who has changed his/ her institution, must attach a copy of such "permission letter" of the Board for the change of institution else the form(s) will be rejected summarily, hence the production of required permission is ensured by the Head of the Institutions.
