

ELIGIBILITY OF (EX / FAILURE) CANDIDATES

(i) The candidates who appeared / enrolled / registered at the SSC Part - I (Class IX) Annual Examination 2019 and also appeared at SSC Part - II (Class X) Annual Examination 2020 but could not qualify up to Supplementary Examination - 2020 whether again appeared or not at SSC - II Supplementary Examination - 2020 & 2021 are eligible to appear at the SSC Part II Annual / Supplementary Examination - 2022 in failure papers.

(ii) The regular candidates who have enrolled / registered and appeared at SSC Part-I (Class IX) Annual Examination 2020 but could not appear at SSC Part - II Annual Examination - 2021 may appear at SSC Part - II Annual Examination - 2022, subject to production of admission certificate (in case of general regular group) for seeking Gap Permission with usual fee Rs.1500/- of Class X with atleast 75% attendance for current Session from the Head of Institution.

SPECIAL INSTRUCTIONS

- 1. MOST IMPORTANT: It must be ensured that in case, of Class IX the regular and private candidates must incorporate, their enrolment and registration numbers respectively, in the relevant column specially provided for this purpose in the examination forms and also attach a copy of the enrolment / registration cards issued by the Board duly attested by the Head of Institution concerned with the examination forms.
- 2. The Board will issue computer generated admission slips to the candidates and centers, hence two photographs of the candidates, one without attestation and the other duly attested by the Head of Institution may be affixed with gum in the relevant columns of the examination form.(Stapler Pin is Not Allowed)
- 3. The particulars of the candidates i.e. name, father's name, surname, Date of Birth and subjects should be written in block letters in the columns provided in the examination form.
- 4. The original marks certificate of last examination & in case of improvement, original permission letter for improvement (issued by the Board) should be attached with the examination forms of Class X.
- 5. Post/Residential / Home address of the candidates may be clearly mentioned in their respective forms in legible letters.
- 6. The attendance in case of General Regular group should be counted and inserted in the examination forms upto _______plus average attendance upto 21.02.2022.
- 7. In case any candidate exhibits irregularity in attendance his/her name may be recommended for with-drawl of the examination form and he/she will not be allowed to take the examination.
- 8. The subjects of the candidate in which he/she intends to appear at the examination be clearly mentioned in the examination form in prescribed column, as per marks certificate / option while getting admission in the Class with selection of subjects. The Board will not be responsible, if any paper(s) is/are left un-entered in the examination form and any entry left unchecked / uncorrected by the School.
- 9. In case of candidate(s) migrated from other Boards, the original eligibility certificate issued by this Board should be attached with the examination form, as well as original marks certificate of last examination.
- 10. Photographs of the male and female candidate(s) must be pasted at proper places in the Exam: form with gum only and should not be stapled.
- 11. The examination forms must be signed by the candidate(s) and the Head of the Institution(s) himself / herself with official stamp (stamp signature is not acceptable).
- 12. In case of Ex-candidate(s), original marks certificate of Class IX / X must be attached with the Examination form
- 13. It has been observed that the forms of the candidate(s) who has/have availed of all the chances and is/are not eligible at the examination is/are forwarded and submitted, resulting hardship to the candidates and the Board for refund of fees etc. In this regard it has clearly been mentioned eligibility of such Ex-candidates who are eligible to appear at this examination. Hence in spite of this, if any form of ineligible candidate is submitted, the Institution concerned shall be responsible

- 14. The Private candidate(s) should attach attested copy of Domicile Certificate and CNIC, in case they are below 18, copy of self / father's / brother's Domicile, CNIC "B" form issued by **NADRA** and duly attested by the Head of concerned institution must be attached with the examination form(s).
- 15. The Private candidate can only fill-in his examination form through the nearest available high / higher secondary school and mention his postal address provided in the CNIC.
- 16. The Private candidate(s) will have to submit / attach the original Birth Date Certificate issued by any Government Hospital, Union Council **OR** Municipal Committee.

The Head of Institutions are requested to kindly fill-in the examination forms carefully ensuring that all the formalities are fulfilled well.
