**Introduction**

The Aga Khan University Examination Board's (AKU-EB's) Middle School Programme (MSP) sets out the basic knowledge, core concepts, and general competencies necessary and appropriate for students as they progress through Grades VI-VIII.

MSP has been specifically designed to provide students with a strong foundation for future learning, growth and readiness at the Secondary and Higher Secondary School level by encouraging students to approach learning differently, recognize linkages across disciplines and move from knowledge to understanding and application of concepts.

AKU-EB's Middle School Programme is self-contained and can be adopted either independently or as a continuum to other AKU-EB qualifications at the Secondary and Higher Secondary level.

**About the Project Portfolio**

AKU-EB's Project Portfolio is a student centered learning approach that enriches the curriculum with its interdisciplinary, research based approach to learning and application to real world situations. Project tasks are developed by AKU-EB based on Schemes of Work that outline key concepts for each grade level. Working on these projects lets students demonstrate tangible learning of key concepts and gives them the opportunity to develop and display key competencies. Schools opting for Project Portfolio are required to complete at least 4 projects in an academic year and submit these along with teachers' assessment and supporting evidence of students' accomplishments. These will be discussed in an annual agreement trial meetings organized by AKU-EB.

## Support to Schools:

Teachers from the schools registering for Project Portfolio receive training in an orientation workshop on how best to facilitate students and how to integrate the projects with the school's curriculum. They further have the opportunity for professional development in Annual Teacher Meeting (ATM) held to validate schools' assessment of their students' portfolios.
