PROCEDURE FOR SUBMISSION OF ENROLMENT / REGISTRATION FORMS

- a. The student who have passed SSC (Part-II) Annual / Supplementary Examinations 2015-2016/2017-2018 will be eligible for Enrolment Annual Examination 2019.
- b. The students who have passed (SSC Part-II) Annul / Supplementary Examinations 2014 or earlier will not be enrolled in class XI as Regular Students in Science Group, however, they can be enrolled in Arts & Commerce Groups Only.
- c. 75^ attendance is compulsory for appearing in the examination, and all heads of institutions must ensure to submit attendance upto 10th of every month in General Academic Branch per decision of the steering Committee of Education & Literacy Department Government of Sindh Karachi.

The Enrolment / Registration Forms must be accompanied with the following documents duly authenticated be head of the institutions:-

- i. Covering letter.
- ii. Original U.B.L CHALLAN(s) / ONLINE receipt of UBL Bank.
- iii. Three copies of fee(s) statement.
- iv. Attested photocopy of Marks Certificate of Matriculation
- (Two) recent photographs of candidates, within college uniform should be pasted with gum at the appropriate place on the Form.
- vi. List of the candidates in an Alphabetical Order, showing date of admission in the institution (in-duplicate).
- vii. The photographs of the candidate should be pasted with gum on the form, failing which the Enrolment/ Registration Form will not be entertained.
- viii. No Dues Letter / Permission countersigning Form of non-affiliated institution (for the year 2018-2019) issued by the General Academic Branch of this Board should be attached at the time of submission of Form(s) (photocopy) at the time of submission of Forms(s), otherwise the Enrolment / Registration Form will not be accepted / entertained.
- ix. Those candidates who are coming from the other Boards should attach the attested copy of Eligibility Certificate, issued by this Board, otherwise the Enrolment / Registeration Form will not be accepted / entertained.
- x. Those candidates who will appear as a private candidates should attach attested Photostat of the Domicile Certificate within the jurisdictions of Board must be produced, otherwise his / her Registration Form will not be accepted/entertained.
- xi. The Candidates who are coming from other Education Boards and entered to appear in HSC Part-II and required to obtain Eligibility Certificate from General Academic Branch of Board and simultaneously are required to get themselves Enrolled by obtaining "Enrolment / Registration Card" from concerned branch for a ppearing at HSC Part-II Annual Examination 2019 failure which their Examination Forms for class XII final Examination of HSC will not be accepted by the examination HSC Conduct Branch.
- xii. However the Enrolment / Registration Card issued by the previous Board for Part-I is not acceptable.
