1. PROCEDURE FOR SUBMISSION OF ENROLMENT / REGISTRATION FORMS

- a. The Enrolment/Registration Forms which can be obtained from the Enrolment Branch with free of cost.
- The age of candidate must not be below 12 years on 01ST March 2019.
- c. The Enrolment / Registration Forms must be accompanied with the following documents duly authenticated by Heads of Education Institutions with:
 - i. Covering letter.
 - ii. Original U.B.L CHALLAN(s) / ONLINE receipt of UBL Bank.
 - iii. Three copies of fee(s) statement.
 - iv. List of the candidates in an Alphabetical Order, showing date of admission in the institution with Class, Date of Birth and S.G.R.# etc; (in-duplicate).
- d. Enrolment / Registration Forms must be completed in all respect. Incomplete Forms will be liable to rejection.
- e. RECENT colour photographs of the candidates should be pasted with gum on the Forms in the given space, failing which the Enrolment / Registration Forms will not be entertained.
- f. No Dues Letter / Permission countersigning Form of non-affiliated institution (for the year 2018-2019) issued by the General Academic Branch of this Board should be attached at the time of submission of Form(s) (photo copy).
- g. Private candidates will provide original "School Leaving Certificate" of Class 5th duly countersigned by the concerned District Education Office. In case of Class 8th Certificate it will be countersigned by the Head Master/Head Mistress.
- h. Those candidates who will appear as a private candidates should attach attested Photostat of the Domicile Certificate within the jurisdictions of this Board C.I.N.C or NADARA "B" Form must be produced, otherwise his / her Registration Form will not be accepted/entertained.

NOTE: Item Nos. (g) & (h) pertain to private candidate(s) only.

2. PROCEDURE FOR SUBMISSION OF FEE

- a. High Schools / Higher Secondary Schools of Hyderabad City will deposit their Enrolment / Registration Fee of S.S.C- Part-I (Class IX) in UBL, B.I.S.E, Latifabad, Branch through Pink colour Challan into A/C No: 010-2748-8.
- b. Outside Hyderabad High Schools / Higher Secondary Schools will deposit their Enrolment / Registration Fee through their nearest UBL, Online Branches in the above Account Number.
- C. Candidates can also deposit the Enrolment / Registration Fees in UBL, BISE, Latifabad, Branch in above Account Number.
- d. Demand Draft will not be accepted at all.
