**REFUND RULES**

**REFUND OF FEE SHALL BE ALLOWED:**

- i) When a candidate is found to be ineligible to appear in the examination concerned in accordance with University Regulations (Original Ineligible letter must be attached with this form).
- ii) When a candidate dies before the commencement of the Examination (Death and legal heir certificate duly attested by a 1st Class Magistrate must be attached with the refund form).
- iii) If the amount paid in excess of prescribed Fee.
- iv) If the amount is deposited wrongly in University A/C which was to be deposited in other Bank A/C or Board (BI & SE) A/C.

**THE FEE WILL NOT BE REFUNDED IN FOLLOWING CASES:**

- i) If the fee is deposited but the Admission Form was not submitted or the Admission Form was rejected by the Examination Branch.
- ii) The fee deposited on the title Registration Fee, Enrolment Fee (both Regular & Private) Correction of Name (inclusive of Father's Name) & date of birth, Duplicate Certificate Fee (inclusive of all type of Certificates), NOC/Migration Fee, Change of Examination Center, Change of Subject, Verification Fee.

**BEFORE APPLYING FOR ANY REFUND OF FEE,**

**OBSERVE THE FOLLOWING CONDITIONS.**

1. A claim for refund of fee shall be entertained only if made within one year from the date of the commencement of the respective Examination.
2. Provided further that in case of private & regular candidates, a deduction of 25% shall be made in all type of refund cases.
