10. Gym management reserves the right to cancel any membership without assigning any reason.
11. All exercises and playing session are done at members or visitor's own risk. Gym management will not be responsible for any compensation.
12. Members are advised to get the doctor's clearance before starting any exercise program.
13. Children under the age of 14 are not allowed to enter in the gym.
14. No allowance will be made in lieu of absence.
15. The loss of a Membership card should be reported to the Front Desk immediately.
16. The Management shall have the right to close part or all of the facilities of gym due to repair, maintenance, expansion of the facilities or special events, without advance notice, and to re-adjust the operating hours of the facilities.
17. The Management reserves the right to amend charges without any notification.
18. Members guests are not allowed to use the facility.
19. Personal servants are not allowed to enter in any facility as guests or as part of the member's family at any time.
20. No adjustment/refund will be made at the time or transfer of membership and the management reserves the right to refuse any transfer without assigning any reason to it.
