#### INSTRUCTIONS FOR THE CANDIDATES

- No candidate shall be admitted into the examination hall without the prescribed admit card and enrolment card, issued by the university. Candidates are liable to expulsion form the examination Hall for failure to produce the University Admit Card, the Enrolment Card and the University Identity Card.
- No candidate will be allowed to leave the Examination Hall until an hour has elapsed from the time when the papers are given or 2) re-enter the Examination Hall after once leaving in finally giving his answer-book.
- Candidates should not write any objectionable or improper remarks in their answer-books. They must not write on the question paper or blotting paper or any material or carry away any writing or scribbling from the Examination Hall. 3)
- During the period of Examination no candidate shall make any noise, or raise any voice to draw the attention of any invigilator. To draw the examination of an invigilator he may simply rise in his seat without making any noise or disturbance.
- No one should smoke inside the Examination Hall.
- Candidates are warned that any breach or attempted breach of any of these or other Examination rules will render them liable to expulsion by the concerned teacher from the entire Examination or any part thereof and to such further punishment as the disciplinary committee may determine.
- Candidates shall write on both sides of the paper in their answer-books. One or two papers of the answer-book may be used for rough work or calculations and the pages so used shall be clearly struck out by drawing a line across it from top to bottom.
- 8) Candidates are required to sign their names as and when directed by the Invigilator to do so.
- In any case not covered by the foregoing rules, reference shall be made to the Chairperson for direction and his/her decision shall be accepted as final.
- 10) Notwithstanding the issue of the Admit Card, the disciplinary committee shall have the right, for any reasons which may appear to them sufficient, to cancel the admission of any candidate to any examination, whether before, during or after the Examination.
- 11) The disciplinary committee may also debarred a candidate from appearing at any subsequent University Examination or Examination and the decision in all such cases shall be final.
- 12) Students called for National duty such as participation in Olympics, National Games, inter-varsities, and going perform Haj would be given exemption in attendance for the actual period of national duty/Haj. These cases would be decided individually.
- A student would be promoted to next higher class upon clearing 80% of courses
  - ii) Under fractional grading system D, D+ and C- grades equivalent to marks between 50 to 60 are allowed for improvement either for individual grades or short of CGPR.
- 14) In case of Walk-out there shall be no re-examination under any circumstances.

INSTRUCTIONS/INFORMATIONS: Ineligible candidates shall not claim any right for the announcement of their result if admit card issued to them inadvertently on the basis of Incorrect/False Informations / Documents, after attestation from the department. Such students may also face a case of fraud with disciplinary action by the University. Students must fill their Name / Father's Name, Seat No., Course No. & Enrolment No. in their own handwriting. In case of any missing information, his/her Admit Card will not be issued.

No materials or electronic devices shall be brought into the room or used at an examination. Unauthorized materials include, but are not limited to: books, class notes, or aid sheets.
