ELIGIBILITY CRITERIA / DOCUMENTS REQUIRED:

01. Candidates must hold a permanent foreign nationality or dual nationality or overseas Pakistani student who has studied and passed HSSC 12th grade examination or equivalent from outside Pakistan and has stayed in the foreign country for the whole duration of the above mentioned course and possesses a certificate from the institution last attended to this effect.
1. Marks certificate of Secondary School Certificate / O Level or equivalent Equivalence Certificate from IBCC
2. Certificate: Marks certificate of HSC / A Level or equivalent Equivalence Certificate with minimum 60 % marks from IBCC equivalence is required.
- 03 SAT-II examination or MCAT with score minimum 550 marks and 500 respectively in each of three science subjects, i.e. Biology, Chemistry, and either Physics or Maths
4. Valid TOEFL or IELTS with a score of 500 or 5.5 respectively.
5. Proof of overseas Pakistanis, she/he has to submit the his/her father/mother/parents' working outside Pakistan.
