It is notified for information and necessary action of all concerned that in view of the Inter Provincial Education Minister's Conference decision(s) and proposed policy of FBISE the Board of Governors (BoG) in its 110th meeting held on 03-07-2020 approved the following promotion criteria for the candidates of SSC & HSSC Annual Examination 2020 of FBISE:.

PROMOTION CRITERIA FOR THE CANDIDATES OF SSC AND HSSC ANNUAL EXAMINATIONS, 2020 OF FBISE

i.	CATEGORY 1 All Grade 9 th and 11 th students are to be promoted to grade 10 th and 12 th respectively. This will allow 100% of regular and private students of 9 th and 11 th grades to advance to the next level. This will cater to a vast majority of students. All these students will get an additional 3% added to their total based of the previous exam. iv.	CATEGORY 4 The remaining students appearing in grade 10 th and 12 th examinations who have failed up to 40% of the Grade 9 th and 11 th subjects will be awarded passing marks. V.	CATEGORY 5 A special examination will be held between September and November for the following categories: a. Those not satisfied with their grade 11 result and want to improve by taking grade 12 exam. b. Those who were taking composite exam and had no grade 11 result to rely on. c. Those wanting to appear in additional subjects d. Those who failed in more than 40% of the subjects in grade 9 and 11 The exam fee of these students will be re-adjusted in the special exams.	CATEGORY 5 A special examination will be held between September and November for the following categories: a. Those not satisfied with their grade 11 result and want to improve by taking grade 12 exam. b. Those who were taking composite exam and had no grade 9 or 11 result to rely on. c. Those wanting to appear in additional subjects d. Those who failed in more than 40% of the subjects in grade 9 and 11 The exam fee of these students will be re-adjusted in the special exams.

Transcripts and Certificates The scores of individual subjects for part II (both theory and

practical) will not be mentioned in the transcripts. Only an aggregate score out of 1100 and an overall grade based on the aggregate score will be awarded to the students for the qualifications.

The Boards should mention in the transcript and in the certificate that the marks awarded for part II is the best prediction of the performance and has been awarded based on the formulae and guidelines approved by the government and recognized by IBCC.

Grade 10th and 12th students who may wish to sit in the special examination for any reasons may inform their respective boards by July 1, 2020. These students will be awarded results transcript or certificates after the special examination.

The layout of result card and Certificate will be same as previous. However, following remarks will be added in the result card:

'The marks awarded for part II is the best prediction of the performance and has been awarded based on the formulae and guidelines approved by the Government of Pakistan.

Grade 10th and 12th students who may wish to sit in the special examination for any reasons may inform their respective boards by 15 days after declaration of result. These students will be awarded results transcript or certificates after the special examination. The result of special examination will be their final result and no claim for formula based result will be accepted.

Moreover, there were certain aspects of the policy under consideration which are not covered in the minutes of Inter Provincial Education Minister's Conference such as cases of improvement, award of Practical marks and those students who are appearing in some papers of SSC/HSSC on the directives of IBCC. Recommendations about such cases were made by the BoG as follows: The house also authorized the Chairman FBISE to decide the hardship cases, if any, arise out of the above policy on merit and in light of the decision made at IBCC

S. No.	Nature of Cases	Recommendation of the BoG
i.	Improvement cases	The students who have passed their complete exams (SSC/HSSC) earlier and have applied for improvement in Annual 2020 will be granted better marks of the two papers of the same subject.
ii.	Award of Practical Marks	Although members of the house were of the view that marks of practical may be awarded as 40% as baseline and 60% on performance in theory portion of the subject. However, the house also authorized Chairman FBISE to discuss the issue with other IBCC members for uniformity. After discussion with other Boards, it was resolved that marks of Practical papers will be granted as per following formula: i. 50% of total practical marks as baseline marks will be granted to all students. ii. Remaining 50% marks will be proportionately calculated on the basis of marks obtained in the relevant theory paper and would be accordingly granted.
iii.	Those students of SSC/HSSC who had applied for facility for improving one or two papers of part-I with their Part-II	These students shall get the 03% marks as per policy.
iv.	IBCC Cases	Special Examination
٧.	Any other type of case not covered in above policy	Special Examination
