- Private candidates are strictly advised to give proper **postal address** in the space given in the examination form otherwise; missing of any document dispatched on the postal address will not be the responsibility of the KIU Examination Section.

- Private candidates who are residing in Gilgit-Baltistan have to appear from the Karakoram International University Gilgit-Baltistan, however, they shall not to opt for any subject or group of subjects not offered any institution affiliated with KIU.
- Examination forms must be completed in all respects. These forms one very recent photograph and one cross-attested photo (Male & Female) may be pasted on the admission form. These photos shall be got attested from the head of an affiliated institution. Fee & required documents must also be attached.
- All the principals/heads of affiliated institutions are requested to note that the particulars of candidates in the examination form be recorded on the basis of college records.
- Copy of notification & examination forms are available for regular/private candidates in the KCBL branches of all Districts of Gilgit-Baltistan on payment of Rs. 20/- each.

 - HSSC- DMC (verified copy if pass from other than KIU Examination).
 - Original fee deposit challan
 - Two recent photographs (not older than 06 months)
