- 1. All the Institutions have to log on to the Board's website www.biseatd.edu.pk for online enrollment module. For details contact 0992-392727, 0992-390153 and 0314-5000363 during office hours.
- 2. Institutions are also required to download/print enrollment of the institution and submit a hard copy of the same in Registration Section alongwith original receipt within the prescribed dates. In case of delay, late fee will be charged.
- 3. No Enrollment return will be accepted after 11-11-2021 in case of Regular Students.
- 4. Particulars of student(s) Name, Father Name, Date of Birth, Admission Number, Date of admission, groups, subjects etc must be in conformity with ADMISSION WITHDRAWAL REGISTER/FORM-B. Any cutting, overwriting, erasing and alteration in above particulars of student(s) will not be accepted.
- 5. Candidates having attained the age of 14 Years would be eligible for appearing in the SSC Part-1 (9th) Annual Examination 2022. The minimum calculation level for date of birth is 31/03/2008.
- 6. No institution is allowed to entertain a migrating candidate under any circumstances without having original migration certificate issued by BISE concerned.
- 7. School to School Migration (Local Migration) will not be allowed under any circumstances after 31-12-2021.
- 8. To avoid double enrollment, it is important to note that enrollment is allowed only once. Before admitting a student it must be ensured as to whether he/she is already enrolled with BISE Abbottabad or otherwise. If a candidate is already enrolled with this Board and he/she seeks re-admission in another institution, he/she must apply to the Board for Local Migration Certificate if otherwise eligible.
 - Student who gets re-admission in an Institution, for such students their old/previous enrollment Number shall be used for future correspondence with BISE Abbottabad. No new enrollment Number shall be allotted to the re-admitted student. Therefore their names must not be sent with the enrollment of fresh candidates. While at the time of admission, their admission forms are sent to the Board by mentioning their old/previous enrollment Number.
- 9. School Leaving Certificate (SLC) may not be issued to student seeking local migration until and unless Local Migration is allowed by the Competent Authority of Board.

- 10. Those students migrating from other Boards for enrollment with BISE Abbottabad will produce verified DMC and attested copy of school leaving certificate (SLC) from institution concerned alongwith original migration certificate at the time of enrollment.
- 11. The Heads of institutions are directed to collect fee and other charges from the student(s) at the end of every month; otherwise the complaint of institution regarding fee and other charges against the student(s) at the time of migration to the other institution/Board shall not be entertained.
- 12. The Heads of Government Institutions are required to deposit Annual Renewal/Affiliation fee on the prescribed bank slip along with covering letter attached duly signed by Principal of the concerned institution.
- Private Institutions are required to deposit Annual Renewal/Affiliation fee for Academic Session 2021-2022 alongwith prescribed renewal form (available at BISE website).
- 14. Enrollment of only those institutions will be accepted who are duly registered with the Khyber Pakhtunkhwa Private Schools Regulatory Authority. Furthermore, private institutions are must submit registration/renewal letter for Academic Session 2021-2022 issued by the Private Schools Regulatory Authority Government of Khyber Pakhtunkhwa and in case of non-availability of letter, enrollment of such institutions will not be accepted.
- 15. An institution must get **CLEARANCE** from Academic Section of BISE Abbottabad regarding outstanding dues if any and in case, there are any outstanding dues then; enrollment will not be entertained by this office under any circumstances.


