2. The following categories of students will be eligible to appear in SSC 02nd Annual Examination 2021: -

- i. All the registered candidates of SSC I & II up to March,2021 (Regular/Ex/Private) whose admission form was cancelled/not submitted for SSC 1st Annual Examination 2021, due to any reason are eligible to apply for SSC 02nd Annual Examination 2021 and will appear in elective subjects as per policy for 1st Annual Examination 2021.
- ii. All those registered candidates of SSC I & II up to March, 2021 who submitted their admission form for SSC 1st Annual Examination 2021 but remained full absent in SSC 1st Annual Examination 2021 for any reason are eligible to apply for SSC 02nd Annual Examination 2021.
- iii. The passed candidates of SSC-II Annual Examination 2021 who intend to improve their Grade/Marks are eligible to apply by re-appearing only in already appeared subjects/papers of their choice in the current course as the case may be within a period of one year of passing the relevant examination.
- iv. The students of SSC I & II Annual Examination 2021 who remained absent (Covid positive cases) in any subjects/papers during the examination and has been given passing marks (33%) as per existing policy can reappear in that subject(s)/paper(s) only in SSC 02nd Annual Examination 2021 on provision of Covid positive report of being effected during SSC 1st Annual Examination 2021. **They will not remit any examination fee**.
- v. IBCC candidates are eligible to appear in SSC 2nd Annual Examination 2021.
- vi. Passed candidates of SSC Part-I Annual Examination 2021 will appear along with Part-II in Annual Examination 2022 for improving the marks/grade.
- vii. Change of subjects/group will not be allowed under any circumstances after final submission of online admission form
- viii. All the Heads of affiliated institutions are requested to ensure that the particulars of candidates on the online admission forms are recorded on the basis of registration cards. Online admission form(s) will not be entertained / accepted without registration number(s).
- ix. No Practical Examination will be conducted for candidates appearing in SSC 02nd Annual Examination 2021.

3. MODE OF SUBMISSION FOR REGULAR CANDIDATES OF SSC-1& II.

Admission data (in soft form) placed on FBISE website for SSC-I& II candidates will be filled in letter and spirit by the institution and submitted online only within specified due dates. No hard/printed copy of admission form and documents (if any) of SSC-I & II regular candidates shall be sent by institution(s) to FBISE office by post except the bank draft (if applicable). A scanned copy of certificate regarding candidate is regular candidate of the institution duly signed and stamped by the concerned principal has to be attached along with the online admission form.

MODE OF SUBMISSION FOR EX/ REGISTERED PRIVATE/IMPROVEMENT/IBCC CANDIDATES. 4.

Admission data (in soft form) placed on FBISE website i.e. www.fbise.edu.pk will be filled in letter and spirit and submitted online only by the candidates within specified due dates. No hard/printed copy of admission form and documents (if any) shall be sent by the candidate to FBISE office by post except the bank draft (if applicable).

MODE OF REMITTANCE OF FEE 5.

For remittance of fee to the FBISE account, the overseas institutions/candidate(s) may exercise one of the following options: -

- Payment may also be made through Bank Draft drawnable at Islamabad (Pakistan) issued in the favour of Controller of Examinations (Conduct), Federal Board of Intermediate & Secondary Education, Islamabad. Any Bank Draft/Electronic Transfer in foreign currency, drawnable in foreign country (Other than Pakistan) will not be accepted at any cost.
