- 2. All the Private candidates are required to submit the Examination Admission Forms completed in all respect, along with their requisite copies of DMCs with <u>TWO</u> latest Passport size photographs (Both Male & Female) duly attested by a Gazetted officer.
- 3. Examination fee should be deposited in Habib Bank Limited and United Bank Limited (UBL) Lakki Marwat Branch. Fee remitted through cheques, Money/ Postal Orders will not be accepted. Partial payment of fees is not admissible.
- 4. Claim of any candidate to have sent examination admission form by post but not received at the office of the Controller of examinations, will not be entertained by the University, but the candidate will be responsible to settle it with the Postal Authorities.
- 5. The Examination Centers will be allotted to private candidates on the basis of their respective permanent addresses as mentioned in the examination admission forms. However, the University reserves the right to allot any other examination center keeping in view the number of candidates and law & order situation in the area. A candidate, who wants to be examined in a place other than his permanent address, must provide proof of his/ her/ parents/ spouse present address and service certificate etc. with the form, duly attested by a Gazetted officer.
