

### 2. THE FOLLOWING CATEGORIES OF STUDENTS ARE ELIGIBLE TO APPEAR IN HSSC 2<sup>ND</sup> ANNUAL EXAMINATION 2024: -

- i. All the registered candidates of HSSC I & II (Regular/Ex/Private) whose admission forms were cancelled/not submitted for HSSC 1<sup>st</sup>Annual Examination 2024 or for prior Examinations due to any reason.
- ii. All those registered candidates of HSSC I & II who submitted their admission forms but remained absent in HSSC 1st Annual Examination 2024 or for prior Examinations due to any reason.
- iii. The candidates who intend to improve their Grade/Marks after passing HSSC Examination can do so if otherwise eligible by re-appearing in any number of subjects/papers of their choice of Part-I or Part-II or both the parts. The candidates appearing in any subject for both the parts involving practical examination shall appear in the practical examination as well. However, candidate neither requires nor can appear in practical if he/she is appearing in one paper of a subject or any one part of the examination.
- iv. The candidates who intend to appear in Additional Subject(s) in accordance with IBCC advice letter.
- v. The candidates who passed HSSC-I in 1<sup>st</sup> Annual Examination 2024 may appear to improve their marks/grade.
- vi. Incomplete Admission form (Draft) will not be accepted for examination
- vii. The candidates having Compartment in HSSC-I Annual Examination 2024 are eligible to appear in HSSC 2nd Annual Examination 2024.
- viii. A candidate appearing in any failure papers / Improvement paper of Part-I OR Part-II will pay full fee of respective
- ix. Fresh candidates are eligible to appear in the examination.

#### 3. PLEASE NOTE THAT:-

- Change of subjects/group cases will not be allowed under any circumstances after final submission of online admission form.
- II. Admission fee shall be remitted at any nearest Habib Bank Limited (HBL), Muslim Commercial Bank (MCB) Branches and through Easy Paisa /Jazz Cash application(s). The System Generated Bank Challan must be deposited within due dates, as per above mentioned schedule before submission of admission forms.

#### 4. MODE OF SUBMISSION OF ADMINSSION FORMS OF REGULAR CANDIDATES OF HSSC 1&II.

- i. The Admission Forms/Data of registered candidates of your institution is available on FBISE website please reexamine carefully and submit to the FBISE after remittance of requisite fee. No hard/printed copy of Admission Form and documents (if any) shall be sent by post by institution to FBISE office.
- ii. Before issuance of Roll No Slip if a Private candidate/Institution wants to delete admission form due to any reason (Not desirous to appear in exam etc) a request will be submitted to the Board alongwith prescribed fee of US\$:50/- per admission form.

#### 5. MODE OF REMITTANCE OF FEE

For remittance of fee to the FBISE account, the overseas institution(s)/candidate(s) may exercise one of the following options:-

- i. The payment may be made through Credit Card (Master or Visa) from FBISE website (preferably for quick credit/fee receipt verification).
- ii The payment may be made through SWIFT "MT-103" (via Commercial channel instead of home remittance(PRI)) for credit into FBISE Pak Rupee Account Swift Code: HABBPKKA IBAN Code No. PK26HABB 0022 1100 5000 2001 at the Habib Bank Limited, FBISE branch, Sector H-8/4, Islamabad (Pakistan)

OR

FBISE US dollar account (IBAN) PK 79 HABB 0022 1179 0068 7511 (for US dollar remittance only) at Habib Bank Limited, FBISE Branch, H-8/4, Islamabad (Nature of fee must be mentioned while preparing Swift MT 103 form/text).

Note:

Receipt of deposited fee through MT103 swift message must be uploaded with the online admission form(s).

- iii. Payment may also be made through **Bank Draft drawn able at Islamabad (Pakistan)** issued in the favour of the Secretary, Federal Board of Intermediate & Secondary Education, Islamabad.
- iv. The institutions/candidates forwarding online admission forms from KSA and UAE may remit the dues/examination fee through following banks to HBL, FBISE account:-
