**1. THE FOLLOWING CATEGORIES OF STUDENTS ARE ELIGIBLE TO APPEAR IN MATRIC TECH 2<sup>nd</sup> ANNUAL EXAMINATION - 2025:**

- All the registered candidates of Matric Tech. I & II (Regular/Ex) whose admission forms were cancelled/not submitted for Matric Tech 1<sup>st</sup> Annual Examination - 2025, prior to Examinations, due to any reason.
- All those registered candidates of Matric Tech - I & II who submitted their admission forms but remained absent in 1<sup>st</sup> Annual Examination - 2025.
- The candidates who intend to improve their Grade/Marks after passing Matric Tech Examination can do so if otherwise eligible by re-appearing in any number of subjects/papers of their choice of Part-I or Part-II or both the Parts. The candidates appearing in any subject for both the parts involving practical examination shall appear in the practical examination as well. However, candidate neither requires nor can appear in practical, if he/she is appearing in one paper of a subject or any one part of the examination.
- The candidates who passed Matric Tech.-I in 1<sup>st</sup> Annual Examination - 2025 may appear to improve their marks/grade.
- The candidates having Compartment in Matric Tech 1<sup>st</sup> Annual Examination - 2025 are eligible to appear in Matric Tech 2<sup>nd</sup> Annual Examination - 2025.
- Fresh candidates are eligible to appear in the examination.
- In case of any difficulty in submission of Admission Form(s), the institution may contact our IT team at phone number 051-9269516 during office hours.

**2. PLEASE NOTE THAT:**

- Change of subjects/group cases will not be allowed under any circumstances after final submission of online admission form.
- Admission fee shall be remitted at any nearest Habib Bank Limited (HBL), Muslim Commercial Bank (MCB) Branches and through Easy Paisa application. The System Generated Bank Challan must be deposited within due dates, as per above mentioned schedule before submission of admission forms.
- An Institution/Candidate applying in the category of disability should mention his/her accessibility need at the time of submitting his/her Admission Form in black and white otherwise he/she will not be entertained. Such candidates will also submit prescribed Proforma designed for said purpose.


**5. DOCUMENTS TO BE ATTACHED ALONG WITH ONLINE ADMISSION FORM**
