**Extension in Application Deadline and Amendment in Eligibility
Criteria for Overseas Pakistani / Dual National (Expatriate) Seats**

With reference to the advertisement published in national newspapers (Jang, The News, Express, Dunya, etc.) under SPL No. 1963 regarding MBBS/BDS admissions in private sector medical and dental colleges of Punjab for Session 2025–2026, the following amendments are hereby notified:

1. Extension of Application Deadline:

The Provincial Admission Committee (PAC), in its meeting held on 19.11.2025, has decided to extend the closing date for submission of online applications for private sector institutions, in order to facilitate candidates seeking admission to the MBBS and BDS programs. The revised admission and application submission schedule shall be as follows:

2. Amendment in Eligibility Criteria for Overseas Pakistani / Dual Nationals (Expatriates) Seats:

In pursuance of the Pakistan Medical and Dental Council's "Medical and Dental Undergraduates Education (Admissions, Curriculum and Conduct) Policy and Regulations 2025", notified on 05.11.2025, the eligibility criteria for Overseas Pakistani / Dual Nationals seats shall be read as follows:

"No candidate shall be eligible for admission to Overseas / Dual Nationals (Expatriate) quota seats in any medical or dental institution unless he or she:

- *holds a permanent foreign nationality, or*
- *is an Overseas Pakistani (being a Pakistani citizen permanently residing in a foreign country), Green Card Holder, Iqama Holder, or Maple Card Holder; and*
- *has studied and passed the Intermediate / FSc / HSSC (12th Grade) examination or equivalent qualification from within or outside Pakistan, duly accompanied by an equivalence certificate issued by the IBCC.*
- *Chemistry and Biology shall be compulsory subjects, and the applicant must have secured a minimum of 60% marks in the intermediate or equivalent qualification."*

All other terms, conditions, and provisions contained in the previously published advertisement shall remain unchanged and continue to apply.
