LL.B PART-I, II & III, ANNUAL EXAMINATION 2024.

In continuation to this office Notification No.Ex/Cond/ 306, 365, 384 & 369 dated 31.10.2025, 07.11.2025, 13.11.2025 and 21.11.2025, It is notified that the date for submission Examination Form for the CANDIDATES of LL.B PART-I, II & II (Fresh/Failure), they may fill Examination forms appearing in Annual Examination 2024.

- Note: 1. The Pakistan Bar Council, Islamabad vide letter No.2042/PBC/SEC/2025 dated 25.10.2025 allowed one year grace time to conduct examination of students, who earlier could not qualify the Examination of LL.B Programme for some reasons. It shall also be kept in mind that this relaxation could not be quoted as precedent in future and nor it should be given to any law student in future by the University.
2. As per permission granted by the Pakistan Bar Council Islamabad vide letter No.2042/PBC/SEC/2025 dated:25-10-2025, The Vice Chancellor, University of Sindh, Jamshoro vide Notification No.SU/G/515 dated 30.10.2025 has been pleased to allow LL.B Part-I & II (Failure) and LL.B Part-III (Fresh / Failure) candidates enrolled only for the session 2014 to 2018 to appear in Annual Examination of 2024, scheduled to be held on the month of November 2025 (only once and last chance) this permission is only granted for one year and this relaxation could not be quoted as precedent in future and nor it should be given to any law student in future by the University.
3. As per Corrigendum issued by the Registrar, University of Sindh vide No.ADMN:/ 3950 dated 18.11.2025 regarding allowing LL.B Part-I, II (Failure) and Part-III (Fresh/Failure) student who enrolled in the year 2014-2018 to appear in Examination of 2024.

The Candidates who did not appear in any part of LL.B (Three years) Examination due to any reason i.e, Part-I, II and III are allowed to fill Examination Form and appear as fresh candidates in all LL.B (Three years) Examination of 2024

Note: The practice should not be repeated in future for any law student/candidate and may not be quoted as a precedent for any law student at any stage in future.

The examination forms need to be submitted within three (03) days of expiry date as above in the office of the undersigned. No examination form shall be accepted after expiry of last date.

- The Principals of the Law colleges are requested to ensure that the candidates are contacted so that they may avail the last chance to fill the examination Form.
- The authorized representatives of Colleges may receive Examination forms on the payment of Examination forms fees. Through Bank Challan from the office of undersigned.
- A complete separate list of candidates (showing particulars in alphabetical order) needs to be submitted in the office of the Controller of Examinations, University of Sindh as per above schedule.
- The Examination Form sent through individual candidate or Registered Post / UMS / Courier Services etc. will not be accepted and University will not be responsible for any loss/misplacement of such examination form(s).
- The principals of the law colleges are requested to make ensure that Examinations Forms are properly filed in accordance.
- In-complete Examination form shall not be accepted and liable to be rejected.
