NOTIFICATION

It is notified for the general information of all concerned; that date for accepting Examination Forms from the eligible candidates for Annual Examination-I 2026, has been announced. The Heads of affiliated institutions are therefore requested to upload the examination forms of their eligible candidates with effect from 03-12-2025 to 06-01-2026, without any penalty.

- The certified fees schedule / structure is annexed with this notification for the candidates of the institutions of Private Sector, failures & improvers of both Public & private sectors.
- The regular and fresh candidates of Govt. (Public) sector institutions
 are exempted to pay examination fees etc; whereas the service / online
 charges of Rs.200/- is applicable on all candidates.

THE INSTITUTIONS HAVE TO PAY REQUIRED FEE THROUGH ONLINE SYSTEM AS PER FEES SCHEDULE ANNEXED WITH THIS NOTIFICATION UP TO 06-01-2026 AT ANY NEAREST ALLIED BANK LIMITED (ABL) ACCOUNT NO.0010015380390118 (AS INDICATED IN THE BANKS LIST). THROUGH ALREADY ADOPTED API SYSTEM.

NO EXAMINATION FORMS WILL BE ACCEPTED AFTER 06-01-2026.

Note:

The Heads of Institutions may charge Rs.100/- (Rupees One Hundred Only) per student to meet the miscellaneous expenses to be incurred upon stationery etc. by the institution.

1. INSTRUCTIONS:-

During uploading the data of Examination forms of SSC-I & II (Class-IX & X) Annual 2026 the particulars of Candidate i.e. Name, Father's Name, Surname, Date of Birth, Marks of Identification, Language & failure subjects etc. may be entered carefully and properly.

Photographs of Male & Female candidate in the prescribed field be posted properly.

Home address and Cell No. of Candidate / Parent must be entered on prescribed column.

- iv. Enrollment number issued by this office must be mentioned.
- v. Permission letter number of Improvement must be mentioned.

vi. In case of candidate is coming from any other Board the Eligibility Certificate number issued by the Board should be mentioned in prescribed column.

The candidates who were enrolled / appeared through any Institution in Class-IX previously the Bio Data of such candidate be uploaded from the same Institution. In case of Transfer to another Institution the TC permission letter number issued by this Board be mentioned.

NB. Fresh picture (other than pasted in Ninth form) be pasted while uploading the form for X class.

2. ATTENDANCE.

In case of regular students the attendance kept by the candidate should be shown in the prescribed column up to <u>06-01-2026</u> average attendance **must be indicated separately**. The minimum attendance required 75% of total period attended.

3. ELIGIBILITY OF CANDIDATES.

- The candidates who were enrolled and have appeared at SSC Part-I Class-IX Annual Examination, 2024 and avail the gap of one year i.e. 2025 are eligible to appear at SSC Part-II Annual Examination-I. 2026.
- ii. The candidates who appeared first time at SSC-II (Class-X) in Annual Examination 2025 and then whether they appeared or not at SSC Part-II Class X Annual/Supplementary Examination 2025 and could not qualify the same are eligible to appear in failure papers of SSC Part-I & II at Annual Examination-I, 2026 as an Ex-Student.
- iii. The candidates who appeared in Class IX in Annual Examination, 2023 and avail the gap of two years i.e. 2024-2025 are not eligible in Class-X Annual Examination-I 2026. However the said candidates are eligible to appear in Annual Examination-I 2026 in Ninth Class IX again as a fresh candidate.
- iv. The candidates who first time appeared at SSC Part-I Annual Examination, 2023 are not eligible to appear at SSC Part-II Annual Examination-I 2026, hence their Bio Data may not be referred to the Board, if so received from any Institution that will entirely be on their own risk and cost and will be rejected.

v. ELIGIBLE CANDIDATE.

- b. Appeared Class-X 2025
- c. Appeared as failure in Class-X 2025.

4. FOR PRIVATE CANDIDATES.

i. Private candidates shall have to produce an attested photocopy of Domicile/ PRC issued by the Deputy Commissioner/District Coordination Officer of concerned district and Primary Certificate of Class-Vth.

ii. Attested photocopy of Computerized National Identity Card must be attached with the Examination Form. In case of candidate is below the age of 18 years, their attested photocopy of Form "B" from Registration Department of his/her Father/Guardian be attached.

The candidates, who have passed their VIII class Examination in 2023 or earlier and V class in 2020 or earlier, may appear in SSC Part-I & II Annual Examination-I 2026, in all papers of Part-I & II combined.
