1. This merit list is developed purely on the basis of data entered by candidates on the centralized Web portal for Admissions in Private Sector Medical/Dental Colleges of Khyber Pakhtunkhwa (https://caspr.kmu.edu.pk). 2. The candidates must deposit Admission Confirmation fee on a Bank Deposit Slip to be provided by the university during placement interviews, failing which the seat will remain as vacant, and the candidate next in merit will be considered for admission in next round. 3. Candidates shall report to the respective colleges and fulfill all other codal formalities. 4. Formula for aggregate determination to be calculated as 10% SSC,40% Fsc and 50% MDCAT results with preference to KP domicile holders as priority one, if any seat fall vacant, then other provinces candidates will be considered for admission. 5. Verification of admitted candidate's documents and their eligibility shall be the responsibility of the college concerned. 6. In case of shifting (Upgradation) from one college to another, the college concerned will re pay the fee to the students within 24 hours so that seats are filled well in time for smooth completion of the process. 7. As per Section 3 of PM&DC regulations 2025 and KMU Admission Policy 2025-26, candidates with less than 60% marks in HSSC/equivalent or less than 55% in MDCAT 2023, 2024, and 2025 are ineligible for admission to MBBS. Similarly, candidates with less than 50% marks in MDCAT 2023, 2024, and 2025 are ineligible for admission to BDS. 8. As per PM&DC Act 2023 Section 17(4) <i>“The MDCAT result of one province shall be valid for the entire country and shall be valid for a period of three years. Each province, Gilgit-Baltistan and Islamabad Capital Territory shall give preference to the students having domicile of their respective province or territory as the case may be.”</i> 9. Mere figuring in this order of merit shall not confer any right of admission on the candidate if he/she is otherwise found ineligible on detection of any error/mistake/fraud/misrepresentation at any stage of admissions.
