HIGHER SECONDARY SCHOOL CERTIFICATE Part-I & II (ANNUAL-I) EXAMINATION, 2026.

It is notified hereby for the general information of all concerned, that the HSSC Part-I & II (Annual-I) Examination, 2026 of the Board of Intermediate and Secondary Education Peshawar will commence in April, 2026. Under the Cluster Based Examination System.

The Last date for the receipt of Online Admission Forms and Fee in the Board Office for the eligible candidates of HSSC Part-I & II (Annual-I) Examination, 2026 is as under:

Admission fee for regular and private candidates must be deposited in any branch of the Allied Bank /Muslim Commercial Bank OR Easy Paisa through online system generated receipt within the Jurisdiction of BISE Peshawar. Admission fee is as under:

Note:

1. No online admission shall be accepted after the prescribe date (i.e. 30-03-2026) under any circumstances. As the admission process is paperless, no hard copies are required to be submitted at BISE Peshawar. However, institutions are directed to retain the admission forms and produce them to HSSC Examination Section in case of any observation/ complication.
2. Candidates are hereby informed that HSSC Annual-I Examination 2026 will be conducted in full course subjects (for both Part I & Part II) for fresh, improvement and re appear cases.

INSTRUCTIONS:

1. In case of improvement, Rs. 500 shall be deposited at the time of receipt of Original Certificate.
2. Institutes shall process all admissions through BISEP online portal. The system will generate a list of online admission forms with the payment challan/ receipt and the Institute needs to deposit the fee within the due date at any ABL, MCB or Through Easy Paisa. The admission forms will be auto received by BISEP online system after fee verification.
3. Private students shall submit their admission forms online through www.bisep.edu.pk. Hard copy of admission form and fee receipt along with SSC Certificate / DMC for Part I and DMC copy of Part II must be kept with himself in case of non-availability of Roll No slip before starting of examination.
4. Regular Roll Number Slips shall be launched at online portal 10 days before the commencement of exam.
5. Private Roll Number Slips shall be available on BISE website www.bisep.edu.pk 10 days before the commencement of exam. Those who fail to receive their Roll Number Slips in time, duplicate Roll No Slips shall be available through OWS (One Window Service) of BISE Peshawar.
6. All those candidates who attempt for improvement of marks shall not be considered as position holders or for any other type of awards, medals or scholarships in HSSC Annual-I Examination 2026.
7. Private candidates who passed HSSC Part-I Examination from other Boards must submit their printed online admission form with the migration certificate and verified DMC from their respective boards for Part-II of the Intermediate Annual-I, 2026.
8. The subject passed with Grace Marks / Aggregate must be included in the subjects selected for improvement, otherwise the candidate will be considered ineligible.
9. Applications for creation of examination centres can be submitted up to 27/03/2026 through Online Portal System. After expiry, no such application will be entertained in any circumstances.
10. The installation of CCTV cameras in examination Halls / Rooms and to link with BISE Peshawar is mandatory for new as well as already existing examination centres.
11. For Additional subject of Biology, two months Lab attendance certificate from any affiliated Govt / Public College within the jurisdiction of BISE Peshawar is mandatory.
12. Candidates of Wafaq ul Madaris who want to take additional subjects must provide attested photocopy of IBCC Equivalency Certificate at the time of admission for HSSC Annual I Examination 2026, otherwise his or her admission form would not be accepted.
13. All those candidates of 12th class who have passed 11th class in HSSC Annual-I Exam 2025 and did not appear in HSSC Annual II Exam 2025 can apply for improvement in Annual I Exam 2026. Regular candidates shall apply through College/School Portal.
