2. The following categories of students are eligible to appear in 1st Annual Examination, 2026

I. All the registered candidates of HSSC (MEDICAL TECHNOLOGIES, INTER TECH, IUASM), DIPLOMAS & PUFP LEVEL 4 & 5 regular/ex candidates whose admission forms were cancelled/not submitted for Annual Examination 2025, prior to Examinations, due to any reason are eligible to appear in the 1st Annual Examination 2026.

II. All those registered candidates of (MEDICAL TECHNOLOGIES, INTER TECH, IUASM), DIPLOMAS & PUFP LEVEL 4 & 5 who submitted their admission forms but remained absent in Annual Examination 2025 are also eligible to appear in 1st Annual examination 2026.

III. The candidates who intend to improve their Grade/Marks after passing HSSC (MEDICAL TECHNOLOGIES, INTER TECH, IUASM), DIPLOMAS & PUFP LEVEL 4 & 5 Examination can do so if otherwise eligible by re-appearing in any number of subjects/papers of their choice of Part-I or Part-II or both the Parts. The candidates appearing in any subject for both the parts involving practical examination shall appear in the practical examination as well. However, candidate neither requires nor can appear in practical, if he/she is appearing in one paper of a subject or any one part of the examination.

IV. The candidates having Compartment in HSSC (MEDICAL TECHNOLOGIES, INTER TECH, IUASM), Diplomas & PUFP LEVEL 4 & 5 Annual Examination - 2025 are eligible to appear in 1st Annual Examination - 2026.

V. Registered candidates are eligible to appear in the examination.

VI. Private candidates are not allowed in (MEDICAL TECHNOLOGIES, INTER TECH, IUASM), DIPLOMAS & PUFP LEVEL 4 & 5.

VIII. Change of subjects/group cases will not be allowed under any circumstances after final submission of online admission form.

IX. Admission fee shall be remitted at any nearest Habib Bank Limited (HBL), Muslim Commercial Bank (MCB) Branches and through Easy Paisa & Jazz Cash applications. The System Generated Bank Challan must be deposited within due dates, as per above mentioned schedule before submission of admission forms.

X. An Institution/Candidate applying in the category of disability should mention his/her accessibility need at the time of submitting his/her Admission Form in black and white otherwise he/she will not be entertained. Such candidates will also submit prescribed Proforma designed for said purpose.

XI. No Examination Fee will be charged from Orphan, differently abled Candidates, prisoners and wards of 'Shuhada' (Certificate/Proof shall be uploaded).
