It is further informed that online admission form is available at the FBISE website i.e. (Link-[https://portal.fbise.edu.pk/adm\\_reg/admissions\\_hkong\\_126/Welcome/optionselectssc](https://portal.fbise.edu.pk/adm_reg/admissions_hkong_126/Welcome/optionselectssc)). The fee to appear in the Exam (for clearance of Compartment/Improvement of result and Fresh Candidates) is **US \$ 230/-** per candidate.

**2. THE FOLLOWING CATEGORIES OF STUDENTS ARE ELIGIBLE TO APPEAR IN 1<sup>st</sup> ANNUAL EXAMINATION 2026: -**

- The candidates who fully or partially fail or remain absent in the First/Second Annual Examinations 2025.
- The already passed candidates shall be eligible to appear for improvement in 1st Annual Examinations 2026.
- The candidates who withdraw their candidatures (name) from appearing in the 1<sup>st</sup> / 2nd Annual Examinations 2025 before issuance of Roll No. Slips are exempted from payment of requisite fee for 1st Annual Examination 2026. However, such candidates will have to submit their admission forms to FBISE as per previous practice.
- Fresh candidates are eligible to appear in examinations.

**3. MODE OF REMITTANCE OF FEE**

**For remittance of fee to the FBISE account, the candidate(s) may exercise one of the following options:-**

- The payment may be made through Credit Card (Master or Visa) from FBISE website (**preferably for quick credit/fee receipt verification**).
- The payment may be made through SWIFT "MT-103" (via Commercial channel instead of home remittance (PRI) for credit into **FBISE Pak Rupee Account Swift Code: HABBPCCA IBAN Code No. PK26HABB 0022 1100 5000 2001** at the Habib Bank Limited, FBISE branch, Sector H-8/4, Islamabad (Pakistan)

**OR**

FBISE US Dollar account (**IBAN**) **PK 79 HABB 0022 1179 0068 7511** (for US dollar remittance only) at Habib Bank Limited, FBISE Branch, H-8/4, Islamabad (Nature of fee must be mentioned while preparing Swift MT 103 form/text).

**Note:** Receipt of deposited fee through MT103 swift message must be uploaded with the online admission form(s).

4. The candidate/Institutions will download his/her Roll Number slip himself/herself from FBISE website: <https://www.fbise.edu.pk> and print it before commencement of examination. FBISE will not dispatch Roll Number slip to any candidate/Institution.
