6. Eligibility for Registration is S.S.C (Science Group) / T.S.C / Matric Technical with at-least 33% Marks as determined by Inter Board Committee of Chairmen (IBCC) Islamabad in its 156th Meeting held on 06th & 07th July, 2017.
