

HIGHER SECONDARY SCHOOL CERTIFICATE (PART-I & II) ANNUAL-I EXAMINATION, 2026

It is hereby notified for the general information of all concerned, that the Higher Secondary School Certificate (PART-I&II) Annual-I Examination, 2026 of the Board of Intermediate & Secondary Education, Bannu will commence in the last week of April 2026.

Admission fee for Regular and Private candidates must be deposited (Through computerized system generated bank challan only) in any branch of National Bank of Pakistan Aitemaad and The Bank of Khyber, within the jurisdiction of BISE, Bannu.

INSTRUCTIONS:


1. All the Registered Government and Private Institutions (Male & Female) within jurisdiction of BISE Bannu are directed to apply through BISE Bannu official portal [Link: portal.biseb.edu.pk/biseb_portal/login](http://portal.biseb.edu.pk/biseb_portal/login) for admission of 11th and 12th Class students and submit a hard copy of the system generated admission list duly signed and stamped by the Head of Institution along with the original deposited bank receipt within due date.
2. Private Students shall submit their Admission Forms through Online www.biseb.edu.pk. Hard copy of computerized Admission Form and Original deposited Fee receipt along with SSC DMC and CNIC (Self/ Guardian) Copies must be attached.
3. Private Roll Number Slips shall be available on BISE Bannu Website www.biseb.edu.pk 15 days before the commencement of examination.
4. Private candidates who had passed SSC/HSSC Part-I Examination from other Boards must submit their Original Migration Certificate, Verified SSC / Part-I DMC / CNIC, Form-B, with Computerized online Admission form for Annual-I Examination 2026.
5. The installation of CCTV Camera in examination Halls/ Rooms and to link with BISE Bannu is mandatory for new as well as already existing examination centers.
6. Application for creation of examination centers can be submitted up to 03-03-2026 through HSSC section, after due date no such application will be entertained in any circumstances, the creation of center is subject to feasibility/ and approval of the competent authority.
7. Heads of institutions are directed to clear all kind of dues from their Regular students well before submitting of examination forms, any request regarding stoppage of Roll No Slips/DMC's etc., as outstanding dues against the candidate / institutions shall not be entertained by the Board.
8. For constitution of center of examination, each Institution shall make available accommodation, furniture as may be required by the Board.
9. All those candidates of 12th class who have passed 11th class HSSC Annual-I Exam 2025, and did not appear in HSSC Annual-II Exam 2025 can apply for improvement in Annual-I Exam 2026. Regular candidates shall apply through College/ School portal.
10. All those candidates of 11th class, who attempted for improvement of Marks in Annual-II Examination 2025, shall not be considered as a position holders or for any other type of Awards/Medals/Scholarships in HSSC Annual-I Examination 2026.
11. For additional subject of Biology (theory and practical) attendance certificate is mandatory to provide at the time of admission on the analogy of additional Mathematics from any affiliated Govt/ Private institution within the jurisdiction of BISE Bannu.
12. Candidate of Wifaq-Ul-Madris who want to take additional subjects must provide attested photocopy of IBCC Equivalency Certificate at the time of admission for HSSC Annual-I Exam 2026, otherwise his/ her admission form will not be accepted.
13. The improvement candidates can attempt maximum up to two (2) times, however candidates having 3rd division can attempt multiple times within four (4) years given that the candidate has not attained higher degree.

Note: Deputy Director IT/ Computer Programmer is directed for uploading on Website and functional online portal for Eligible candidates within specified dates as above along with computerized online system generated Receipt.
