NOTIFICATION

Consequent upon the recommendation of the *Semester Rules and Regulation Review Committee*, *The University of Haripur* put forth in its 22nd meeting held on March 02, 2026 and its subsequent endorsement by the *Academic Council* in its 32nd meeting held on March 04, 2026 vide Agenda Item 32.2 (1), the Competent Authority (viz. the Vice Chancellor) is pleased to approve the following amendments in Section 12 of *The University of Haripur Semester Rules and Regulations for Undergraduate Academic Programs (Revised 2023)* and Section 9 of *The University of Haripur Semester Rules and Regulations for Graduate Academic Programs (Revised 2023)* regarding payment of **Semester Dues in Installments**, effective from **Spring 2026** semester:

1. *There will be two installments in a semester for payment of semester dues.*
2. *First (1st) installment will be admission and other charges excluding Tuition Fee (in case of 1st Semester) and other charges excluding Tuition Fee (in case of subsequent semesters).*
3. *First (1st) installment will be submitted as per recommendations of Treasurer Office within the due dates otherwise prescribed fine on late dues submission shall be applicable as per the University approved rate.*
4. *Second (2nd) installment will be submitted before commencement of mid-term examination, failure to which the student shall be liable to submit full late fee fine as per the University approved rate.*
5. *While applying for payment of semester dues in installments, students will be bound to submit an affidavit signed by their parent/guardian committing to submit second (2nd) installment before the commencement of mid-term exam [i.e. no later than the eight (08) weeks of the commencement of classes/semester.] Failure to pay the second (2nd) installment on time will incur a fine as per the University approved rates [read in conjunction with Section 12.2 and Section 9(B) i.e. Semester Dues for The University of Haripur Semester Rules and Regulations for Undergraduate Academic Programs (Revised 2023) and The University of Haripur Semester Rules and Regulations for Graduate Academic Programs (Revised 2023) respectively.]*
6. *In case of a student getting the benefits of installments, such student shall be eligible for fee refund as per policy.*
7. *Further, in case of non-payment after commencement of mid-term exam, the defaulter student will not be allowed to sit in the terminal examination.*
8. *The application will be processed on a prescribed pro forma Annexure 7 obtainable from University of Haripur website / concerned department (Copy attached).*

It is further notified that the facility of payment in instalments will be available from the Spring 2026 semester, to facilitate students desiring to avail this option.

This is issued with the approval of the Vice Chancellor, in anticipation of the approval from the Syndicate.
