C I R C U L A R

In pursuance of Services, General Administration and Coordination Department Government of Sindh Notification No.SO(CTC)(SGA&CD)10-11(144)/2026 Dated 10-03-2026 and Universities & Boards Department circular No.SO(G)DDO/U&B/Circular/02/2026 Dated 10-03-2026, it is hereby circulated for information of all the concerned that the People's University of Medical & Health Sciences for Women-Shaheed Benazirabad shall observe the following austerity measures with effect from 11-31 March 2026.

1. 100% online classes will be started for which Deans of Basic Medical Sciences will make necessary arrangements in coordination with IT department.
2. Fuel provision will be cut short to 50%. In case where fuel is not provided & allowances is given instead there will be 50% deduction from POL allowance.
3. 60% of official vehicles will be grounded which includes the vehicles of Vice Chancellor, Pro-Vice Chancellor, the Registrar, Director Finance, Project Director, Controller Examinations, all Deans and the Principal and three students bus points.
4. 20% reduction will be made in ERE budget. Office of the Project Director and Finance Director will coordinate to implement this reduction.
5. Complete ban on purchase of vehicles will be enforced and no purchases of durable items for next 02 months except the IT procurement will be allowed after scrutiny by the concerned Government bodies.
6. Clinical Faculty Members / Essential Service Staff and Hospital posted staff will perform their duties as per the roster.
7. Four days work will be observed except the offices of Registrar, Finance Department, Project Director Staff, where 50% staff will be present.
8. Statutory body meetings, if required will be held on online mode.
