NOTIFICATION

No.0135/Notif/REG-ACAD/LUAWMS/911-935: In compliance with the instructions issued by the Colleges, Higher & Technical Education Department, Government of Balochistan vide Notification No. SOC-II-1-1(18)MISC/2026/801-816 dated 09-03-2026, and the Services & General Administration Department (S&GAD), Government of Balochistan vide Notification No. SGA (Admin) 26-2/2026-S&GAD dated 10-03-2026 and subsequent Notification No. SGA (Admin) 26-2/2026-S&GAD dated 11-03-2026, and further Notification No. DS(Admin)/1-3(3)/2026/CH&TED/260-75 dated 11-03-2026, the Competent Authority of Lasbela University of Agriculture, Water and Marine Sciences, Uthal, in view of the prevailing global and regional situation, has decided that the academic and administrative activities at LUAWMS and its Sub-Campuses shall remain closed till 23-03-2026 (including Eid holidays).

2. The University shall resume its academic and administrative activities in accordance with the following Government instructions/directives:

- i. A four-day workweek shall be observed (from Monday to Thursday).
- ii. Friday, Saturday, and Sunday shall be observed as off days.
- iii. Meetings of statutory bodies and all other official meetings shall, as far as practicable, be conducted through virtual/online platforms or teleconferencing.
- iv. POL/Fuel consumption shall be reduced by 50%, and sixty percent (60%) of official vehicles shall remain grounded.
- v. There shall be a complete ban on the purchase of new vehicles.
- vi. There shall be a complete ban on foreign tours/visits.
- vii. No seminars, trainings, or conferences shall be arranged without prior scrutiny and approval of the Competent Authority.
- viii. No official dinners shall be hosted.

3. These instructions/measures are aimed at ensuring institutional responsibility and national solidarity by extending full cooperation in support of the Government's efforts toward austerity and conservation of national resources.

4. All Deans/Chairpersons/HoDs/Directors/Heads of Departments/Sections are hereby directed to ensure the effective implementation of the above directives in true letter and spirit. Furthermore, all Administrative Section Heads shall devise and submit a comprehensive roadmap to ensure the smooth conduct of routine affairs in accordance with the aforementioned instructions.
