1. The Heads of the institutions are advised to adopt the procedure of Online Registration through portal system (www.bisedik.edu.pk) for the regular students of 1st year class and submit hard copy along with requisite fee within due date to this office for confirmation of fee and students as well. In case of late submission of hard copy after online registration as per schedule mentioned above a penalty @ Rs.50/- per student per day shall be charged. Manual registration of the student shall not be entertained in any case.
2. The Heads of Institutions are required to put the subjects and scanned Photo of each student through portal system.
3. The Institutions concerned must ensure regular class attendance within the college of all such students whose cases are submitted via online registration list for confirmation, failing which application(s) of such student will be entertained for registration in other college without any prior permission/cancellation letter.
4. The Heads of Institutions are advised to submit the original migration certificates and SSC DMC copy /copies of the students migrating from other boards along with registration returns for 1st year registration to this office at the time of confirmation. If an institution fails to provide the same, their applications shall not be entertained and the students name shall be excluded from the registration list
5. The heads of the institutions are advised to maintain proper admission withdrawal register (AWR) of their students and send registration of students in accordance with the said AWR to avoid any missing, errors and irregularities.
6. The heads of institutions are required to submit the following documents of regular students of HSSC who have been migrated from other boards(s), within fortnight for registration in 1st & 2nd year class.

01	Verified SSC DMC from the Board Concerned
02	Verified DMC of Part-I from Board Concerned
03	Countersigned copy of School / College leaving certificate
04	Registration 'return along with covering letter duly signed by the Head of Institution with official seal
05	Original-Migration Certificate
06	Prescribed fee 1500/-

7. Migration from one institution to another shall not be allowed after 31st December 2026 of the current-academic year.
8. The admission of students on scholarship basis specially in Privately Managed Institutions in 1st and 2nd Year class under specific bond/ agreement with the students at the time of admission is not liable to detain students Migration to other Institution/ Board and such bond/ agreement shall not be acceptable/ entertained by this office for such purpose therein.
9. At the time of Migration of the student from one institution to another, the Board is not bound to entertain any complaint by institution regarding the outstanding dues against the students.
10. If a regular student remains absent from the institution for 07 days without prior permission/ information and the same is not reported to this office within fortnight, the complaint lodged against the student by the Institution shall not be entertained.
11. Particularly the principals of the Board privately managed institution are directed never to admit a student in 1st & 2nd year class until

12. Original migration certificate form other Board and School leaving certificate is submitted. In case of non-provision of the same the penalty shall be levied on the institution.
13. Upper age limit for male student of 1st year at the time of admission should be 19 years.
14. According to Board Rules the renewal of affiliation of an institution for the academic year is mandatory, otherwise registration Portal will not open for the registration of students.

15. The heads of institutions are advised to provide authentic and duly verified specimen of their signatures along with stamps to avoid forgery in their signatures & stamps (in case of migration or other issues)
16. The heads of institutions are advised strictly to provide their telephone/Mobile numbers, full mailing address and E-mail address, if any to this office for ready use.
17. Time limit for change of the subject(s) /Group in part 1 class examination is one month after closing/submission of admission.
18. The registration fee shall be deposited in any HABIB BANK LIMITED and NATIONAL BANK OF PAKISTAN branches.

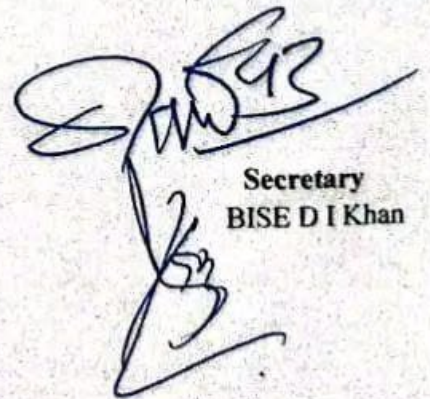
