REGISTRATION NOTIFICATION

It is hereby notified for general information of all concerned that the schedule of online registration for Intermediate (1st Year/11th) class for the academic year 2026-27 is as under:

- The Heads of the Institutions are advised to adopt procedure for online registration through portal system (portal.biseb.edu.pk) for class 11th regular students.
- The Heads of Institutions shall maintain proper Admission Withdrawal Registers (A.W.R.) and ensure that students' registration is submitted online with accurate subjects, information, and fresh photographs as per the A.W.R, Form-B, Migration/DMC. The Head of the Institution shall be responsible for any incorrect entry, cutting, erasure, alteration, or discrepancy in the registration.
- The Registration Fee shall be paid via 1Bill Voucher using any mobile banking App @NBP etc. or deposited at any NBP Branch specified on the computer-generated fee receipt within the jurisdiction of BISE, Bannu.

- Submit registration hard copy along with requisite fee** within due date to this office for confirmation of fee payment and registration, otherwise fee shall be charged as per notification. In case of non-submission upto 30-11-2026 **penalty @ Rs.50/- per student per day shall be charged.**
- Payment in excess of the submitted cases for registration shall lose entitlement for refund nor to be accepted for the next registration of the other student(s) if any.
- All Heads of the institutions are directed to submit attested and verified copies of NADRA Form-B, CNIC by them of the concerned students.
- The Head of the intuitions are required to submit the following documents of regular students of HSSC, who have migrated from other Board(s) within fortnight for registration in 11th & 12th class.

1.	Verified SSC/HSSC(Part-I) DMC from the Board Concerned.
2.	Registration Hardcopy along with covering letter of the Head of Institution with seal
3.	Original Migration Certificate.
4.	Domicile Certificate Copy
5.	Prescribed Fee

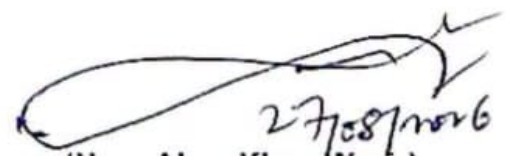
- No institution is allowed to admit a migrating candidate under any circumstances without having original migration certificate and verified DMC issued by BISE concerned. Otherwise, Registration of other Board migrated candidates shall not be processed if the institution fails to provide the required documents at the time of submission of Registration.
- The time limit for change of Subject/Subjects/Group in the Part-I Examination will be one month after closing of Registration/ confirmation of Registration.
- Migration (College to College and Higher Secondary to Higher Secondary School) shall not be allowed after **31st December, 2026** of the current academic year, subject to fulfilment of codal formalities notified by this Board from time to time. Computerized Generated Fee Receipt of Migration ought to be submitted in Registration/Migration Section of this Board within 15 days.
- The Head of the Institutions are advised to provide authentic and duly verified specimens of their signatures along with stamps to avoid forgery in their signatures & stamps (in case of migration or other issues).

12. The Registration of a student on scholarship basis, especially in private institutions, in 11th /12th class under specific Bond/Agreement with the student(s) at the time of admission is not liable to detain a student migration to other Institution/Board and such Bond/Agreement shall not be acceptable by this office for such purpose therein.
13. **The Heads of the institutions are required to collect fee and other charges from the student at the end of every month. Otherwise, the complaint of the Head of Institution regarding fee and other charges against the students at the time of migration to other Institution/Board shall not be entertained.**
14. If a regular student remains absent from the institutions/college for 7 days without any prior permission/information's and the same is not reported by the head of Institution within fortnight to this office, the complaint lodged against the student by the Head of Institution shall not be entertained.
15. The institution shall ensure regular attendance of all registered students; failing which, such students may seek admission/registration in another institution without prior permission or cancellation from the previous institution.
16. Upper Age limit of the student for 11th class is 19 years for male students. Female students are exempted.
17. While granting admission, it must be ensured that the student is not already registered with BISE Bannu. Already registered students are ineligible for new registration. In case of a student re-admission in 11th Class, the expired/old registration number shall be communicated for necessary information to this office, if otherwise eligible.
18. The Registration of the students will be subject to the renewal of Affiliation; all those Institutions that have outstanding dues must clear before Registration.
19. The head of the institutions are directed strictly to provide their Telephone/Mobile Numbers, full mailing address and E-Mail address, if any, to this office for ready use.
