- Result Cards/ Transcripts/DMCs etc. of Bachelor's/Masters Degree showing CGPA/Grade/Division and exact date of declaration of results and above degrees (if any).
- Self Domicile Certificate (**SDC**).
- In case of Govt. Servant, Original Departmental Permission Certificate (**DPC**) complete in all respects issued by an authorized officer of the controlling department.
- Equivalence Certificate from HEC in case of possessing foreign degree or a degree other than the advertised one.
