2. In all cases eligibility of the candidates shall be determined as per Commission's policy laid down in General Instructions displayed at FPSC's website. From requisition of documents it should not be presumed that the candidate has been shortlisted for interview as his/ her eligibility is to be determined in view of documents and merit position.

3. Eligibility of the candidates in all respects shall be reckoned upto the closing date (i.e. 22.6.2020).

You are cautioned that requisitioning of Bio-data form and allied documents to determine eligibility shall not vest any right in you for the post until you are shortlisted on the basis of advertised merit and relevant Provincial / Regional quota as per policy of the Commission. In case any candidate who fails to furnish the Bio-data and requisite documents within stipulated time or furnish incorrect/ incomplete information, their candidature shall be liable to rejection and no alibi or excuse shall be entertained subsequently.
