# **NOTICE FOR SUBMISSION OF DOCUMENTS**

Subject: <u>RECRUITMENT TO THE POST OF GRAPHIC OFFICER (BS-16), GHQ, MINISTRY OF DEFENCE.</u>

#### Dear Candidate,

Referring online applications and subsequent appearance in Screening (MCQ)/ Written (Descriptive) Examination for the subject post, following candidates are advised to furnish BIO-DATA along with attested copies (with name stamp of attestation officer) of requisite documents as mentioned below, within 15 days (up to 24<sup>th</sup> Feb, 2022) of placement of this Notice on FPSC website, through Registered Post/Courier to determine their eligibility. It may however, be understood that asking of requisite documents should not be inferred that the candidate have been shortlisted for interview and their eligibility in all respects in terms of advertised conditions shall be determined after scrutiny of their documents:

- a) **Bio-data** form duly signed and filled-in completely (copy enclosed)
- b) Two latest **Photographs** (Passport size).
- c) Valid Computerized National Identity Card (CNIC).
- d) Self **Domicile** Certificate (SDC).
- e) Secondary School Certificate (SSC)/Matric (showing date of birth) and Higher Secondary School Certificate (HSSC)/ Intermediate issued by Secretary, Board of Intermediate and Secondary Education. In case of 'O' level and 'A' level an equivalence certificate from Inter Board Committee of Chairmen (IBCC).

### f) INTERMEDIATE.

- g) Degree(s) and Transcripts/ Result-Cards/ DMCs showing duration of study period, credit hours with **proof** of CGPA/ Grade/ Class with credit hours and **Result Declaration Date**, issued by Controller of Examination from a University recognized by Higher Education Commission (**HEC**) to determine eligibility.
- h) Wherever an equivalence of the required degree is to be claimed by a candidate, an equivalence certificate issued by HEC/PEC/PMC/PNC may be furnished to FPSC to authenticate the claim.
- i) Valid **Registration** with HEC/PEC/PMC/PNC and such other institutions where applicable (if any).
- j) Ten (10) years post qualification experience in Graphic arts viz:- (a) Press advertising and Publicity. (b) Publication designing and layout. (c) Title designing and animation of films. (d) Calligraphy (English) and typography. (e) Lithography viz:- (i) Colour separation (Line); (ii) Film making (Line and half-tone); (iii) Film mounting (Colour and black and white). (iv) Complete knowledge of all kinds of printing i.e. off-set, letter press dye stamping and ornamental printing. OR Post Inter Diploma in Printing and Graphic Arts with three (3) years post qualification experience as detailed above.
- k) **Experience** Certificate (Post Qualification) with Job description and exact dates as per detailed Experience Format (Annex-A available on FPSC's website), **where applicable**.
- 1) In case of **Government Servant**, Original Departmental Permission Certificate (**DPC**) showing exact date of appointment and domicile on FPSC's prescribed format (available on FPSC's website) duly signed and stamped by Head of the Department/ Division/ Ministry (Official stamp must be affixed).
- m) In case of **Non-Test** Case or **UNDERTAKING** provided by the candidate at the time of examination, Original **Treasure Receipt** (**TR**) being application fee deposited on or before the closing date of the advertisement in the Government treasury or in a branch of National Bank of Pakistan or in a State treasury, authorized to transact business on behalf of Government.
- n) Medical Certificate (if required/advertised) and Proof of Age Relaxation (if claimed).
