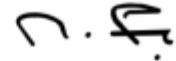

All the Affiliated Govt:/ Private Institutions (Male & Female) are directed to use Online Admission Module (OAM) on www.biseb.edu.pk or portal.biseb.edu.pk for admission of 9th and 10th Class students through a specific login (Username and password) already in use for Online Registration, and submit a hard copy of the system generated admission list (correct) duly signed by the Head of Institution along with the original bank receipt (system generated) within due date.
2. Private Fresh Candidates of 9th class must submit original School Leaving Certificate (issued by Govt: Primary / Middle or Private Schools) duly countersigned by DEO concerned along with admission form with CNIC / Form (B) copy (own), However, those candidates having original School Leaving Certificate issued by Govt: High School are exempted from the counter signature. Private Online Admission forms of Male & Female Candidates will be accepted duly attested by the Principal / Headmaster / Headmistress of the High / Higher Secondary School within the jurisdiction of BISE, Bannu.
3. Private candidate who has never attended any institution can also apply for admission in class 9th subject to submission of attested copy of Form (B) (NADRA) / CNIC or Birth Certificate issued by the Secretary, Union Council, duly countersigned by Medical Superintendent along with online admission Form and fee within due date.
4. A candidate migrated from other board for class 10th will have to appear in class 9th Practical Examination, if he/she has not taken Practical Examination in that board.
5. The subject(s) passed with grace marks/aggregate must be included in the subjects selected for improvement, Furthermore, if the Candidate has not improved marks in that particular subject, the candidate will be considered as MNI (marks not improved).
6. Head of the Institutions Govt/Private are directed to clear all kind of dues from their students well before submission of examination forms, any request regarding stoppage of Roll No. Slips/ DMCs etc. as outstanding dues against the candidate shall not be entertained by the Board.
7. Any concealment in information i.e., DOB, Picture, PHA, Form (B) / CNIC etc. in admission/form, by the Institution/ Candidate shall be dealt as per conduct of exam: rules accordingly.
8. Applications for Creation of New Examination centers can be submitted up to 14-01-2026. Thereafter no application will be entertained under any circumstances.
