Important Instructions:


1. A forwarding letter from the Head of Institution along with the Fee Statement (in duplicate) and the list of candidates whose examination forms are being submitted must be attached. The fee statement must accompany even a single form; otherwise, the forms will not be entertained.
2. Examination form will not be accepted directly from any candidate at the Board's office. Forms will only be accepted through an authorized representative of the concerned institute.
3. All the Heads of Institutions must submit the examination forms within the due date fixed by the Board, either through their authorized representative or by post, ensuring that the forms reach the Board's office as per the schedule.
4. If, for any reason, forms are returned to any institution for correction or compliance, a running penalty shall be charged if the required compliance is not made within the given period.
5. All the Heads of Institutions are requested to ensure strict compliance of all the instructions regarding collection of examination forms, deposition of fees, and mode of dispatch.


